Patty Mathison, April Niemela and Ken Mathison gave the board a presentation on IDLA (Idaho Digital Learning Academy). These teachers along with Dorothy Tiede took classes to be able to present IDLA classes to students for credit recovery, early college courses and advance classes.

Mrs. Bledsoe gave an update to the school board of the progress in finding a Football Field Construction Manager, which was not very productive. She will contact LCSC to find out about their surplus items since they are updating their baseball complex. Trustee Weeks moved and Trustee Johnston seconded to have Trustee Bledsoe contact Mr. Briggs to get an estimate of having the documents drawn up which will enable the district to go out for bids.
